Emails - The emails are provided in 2 formats. When possible, I provided you with copies of the Outlook files. However, occasionally that was not feasible because the emails contained deliberative materials or attachments that held deliberative materials. When that occurred, I created pdfs of the emails for you. If a pdf does not have any redactions visible, please assume that it was provided to you in that format because an attachment was subject to redaction. All of the redactions were done pursuant to the FOIA exemption (b)(5).

Calendars - The calendars are provided in 2 formats. For all calendar events after April 2018, I was able to send you a copy of the actual Outlook file. As you are aware, prior to April 2018, the Commission was using a google based system. Despite our best efforts, I could not find a way to send you the google calendar events, except by inviting you to every meeting. As an alternative, I have created pdfs for the weeks (or months if there were so few activities) of the Commission's calendar prior to April 2018. I recognize that this is not in the native format you requested, but no alternative could be found after months of searching.

Update on your Requests - The email and calendar files being released today are responsive to all of your open requests. Given their release, below are details on the status of each of those requests. As you will see, all but 2 are closed as of today. Our current estimate is that we will close the final two by Thursday, September 10.

* 2018-SP-01 - With the release of the emails and calendars, it is our belief that all responsive records have been released to you. As a result, this request is closed in our system.

* 2018-SP-03 - With the release of the emails and calendars, it is our belief that all responsive records have been released to you. As a result, this request is closed in our system.

* 2019-CP-01 - With the release of the emails and calendars, it is our belief that all responsive records have been released to you. As a result, this request is closed in our system.

* 2019-SP-01 - With the release of the emails and calendars, it is our belief that all responsive records have been released

to you. As a result, this request is closed in our system.

* 2019-SP-04 - With the release of the emails and calendars, all but five documents have been released to you. Those five (listed below) were withheld in their entirety under exemption (b)(5) of FOIA. As a result, this request is closed in our system.

* MFR on meeting with DOD Office of Net Assessment in October 2018

* MFR on meeting with CNCS in December 2018

* MFR on meeting with US Public Health Service Corp in December 2018

* MFR on meeting with Disaster Response Federal agencies in December 2018

* Talking Points for Chairman Heck's keynote at the SEA event in December 2018

* 2020-SP-08 - Several documents are still being reviewed and released. This request is open in our system, and we anticipate providing all appropriate records by September 10.

* 2020-SP-29 - You should have received a separate email today (September 4) responding to this request. Several documents are still being reviewed and released. This request is open in our system, and we anticipate providing all appropriate records by September 10.

* 2020-SP-33-You should have received a separate email today (September 4) explaining the denial of this request. It is closed in our system.

Reminders - As you are aware, if you would like to appeal the handling of your requests, you must send a written request appealing the decision. Normally, you would have 90 days from the date of this notice to appeal; however, given that the Commission will cease to exist on September 18, 2020, we ask that you submit your appeal no later than September 11. The appeal request should be clearly marked with the words "FOIA Appeal" and may be sent to the Commission's email, FOIA@inspire2serve.gov; the Commission's website, www.inspire2serve.gov; or to FOIA Appeals, National Commission on Military, National, and Public Service, 2530, Suite 1000, Box No. 63, Arlington, VA 22202. For more information about the appeals process, please see our FOIA regulations on the Commission's website.
